1 APOLOGIES

84 An apology for absence was received from Mrs Ann Stanbrook, Footpaths Officer.

2 DECLARATIONS OF INTEREST & ALTERATIONS TO THE REGISTER

85 None.

3 MINUTES OF THE MEETING HELD ON 20 JULY 2011

86 It was proposed by Cllr Mrs Heyburn, seconded by Cllr Budd and agreed the minutes of the meeting held on 20 July 2011 be signed as a true record.

4 MATTERS ARISING

87 No matters were raised.

5 VACANCY

88 The vacancy remained.

As Cllr Filmer and Mr Wilson were present, it was agreed to vary the order of the agenda. The Chairman then suspended the meeting to allow Cllr Filmer and Mr Wilson to speak

13 HIGHWAYS AND TRANSPORT**89 a Fenn Corner Roundabout.**

Cllr Budd said that in the last few days a barrier had appeared on Fenn Street just before Fenn House Farm and that some of the cycle track markings had been "greyed out". It was assumed this had been an attempt to shorten the cycle lane as promised but the original markings were still visible and the attempt was ineffective. Cllr Mrs Heyburn complained about the barrier. She frequently walked

to High Halstow and the barrier meant she now had to walk in the road as the verge was completely taken up by the barrier. She felt this made it much more dangerous, especially for pedestrians. Mr Wilson explained the legalities of the contract for the works. The contractor was responsible for the works and the site had not yet been handed over to Medway Council, but he would take the comments back to the contractor. Mr Laphorn asked if he could plant a tree in the centre of the roundabout at his own expense. He was informed that this would compromise the contract and could be used as an excuse for non compliance of works by the contractor. Mr Wilson said that they were in dispute with the contractor over a number of things and that the retention had been reduced, but that the money that remained to be paid more than covered the items that needed rectifying.

90 **b Ratcliffe Highway at St Mary's Cottages**

Mr Wilson said that the scheme outlined in a letter from Chris Rogers had been prompted by complaints on speed of passing traffic Cllr Filmer said he had investigated the imposition of a speed limit but the criterion was based on accident volumes and a speed limit would not be able to be enforced. Cllr Khatkar asked about the cost of implementing the scheme and said it was a waste of money. After a long discussion, during which the residents present who used Hall Road confirmed it was difficult turning out of Hall Road because of the speed of traffic at this point, Mr Wilson agreed to speak to Mr Rogers about minor amendments to the scheme and to consult more widely than just the residents of St Mary's Cottages.

The Chairman thanked Cllr Filmer and Mr Wilson for their attendance and re-convened the meeting.

Cllr Mrs Heyburn read the Footpaths Officer's report. The paths were clear but ploughing had been done and it was to be expected some paths might be muddy following any rainfall.

The tree surgeon had been asked to provide a quotation to do the autumn/winter work in the reserve and would be asked to contact Cllr Mrs Heyburn so that she could meet him on site.

103 **c Pond**

Laverock Tree Care had given an estimate for tree works at the pond, subject to the cost of the electricity being cut off to enable work to one off the trees to be done. It was proposed by Cllr Budd, seconded by Cllr Mrs Heyburn and agreed by 2 votes for and 1 abstention that the works go ahead, subject to a firm price with a maximum of £1,250.

104 **d Notice Boards**

A letter had been received from the resident of 1 St Mary's Cottages, saying that the noticeboard close to his property by the side of the Ratcliffe Highway obscured his sightlines from his drive. The Clerk said that she had to park in Hall Road, cross the Highway and walk up and she was always concerned about the danger. Cllr Budd said the door was always coming open and this was a hazard to traffic and he queried that anyone looked at it as was dangerous to do so. He proposed the notice board was removed. This was seconded by Cllr Mrs Heyburn and agreed.
